#### <u>ORDER</u>

- 1. CA (CAA) 4110/MB/2019 was allowed by NCLT, Mumbai on 21.02.2020. In the order, the Tribunal at the request of the petitioner had stated that they are convening and holding the meeting of the equity share holders of the applicant company on 22.06.2020 at 11:00 a.m. at Walchand Hirachand Hall.
- 2. The petitioner further mentions that due to the Covid-19 situation prevailing in the country and in view of the social distancing restrictions imposed during the lockdown, the applicant company was not able to hold physical meeting of its equity share holders on 22.06.2020 as was directed in the Order dated 21.02.2020.

The applicant company is desirous to hold the meeting of the equity shareholders on 09.10.2020 at 12:00 p.m. through video conferencing as per applicable procedure mentioned in the Ministry of Corporate Affairs (MCA) circular no. 14/20 dated 08.04.2020 read with circular no. 17/2020 dated 13.04.2020 issued by the MCA.

- 4. The counsel for the petitioner during the course of the hearing mentioned that he undertakes to abide by the terms and conditions and procedures as enumerated in these circulars.
- 5. The Bench allows the petitioner to hold the meeting of the equity share holders on 09.10.2020 at 12:00 p.m. fulfilling the terms and conditions and procedures as enumerated in the circulars mentioned above. The Bench however directs that the petitioner to provide in detail through affidavit the manner in which the terms and conditions and procedures as enumerated in those two circulars have been abided and followed by the petitioner in the equity share holders meeting.
- 6. The order dated 21.02.2020 to the extent as mentioned above regarding convening the meeting of the equity share holders of the applicant company stands amended and rest of the order dated 21.02.2020 stands as it is.
- 7. The bench also, based on the request made by the Petitioner, agreed that wherever it is not possible to deliver the notice to the statutory authority physically, the petitioner may be allowed to deliver it to through alternative mode of service like through registered email address.
